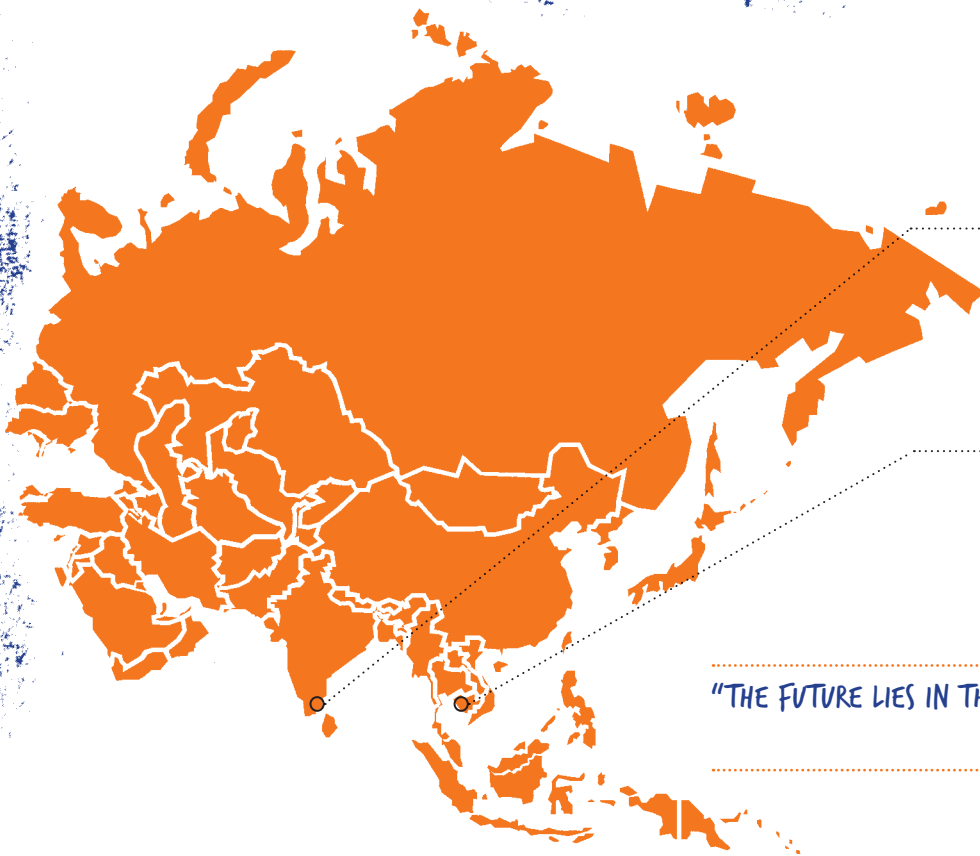

Presidents Report

Dear Friends of Assisi, on behalf of the Committee of Management (CoM) of Assisi Aid Projects (Assisi), I would like to thank you for your support over the past year.

In India, through Assisi Farm & Training Centre (AF&TC) led by Sr Stella, Assisi has delivered projects designed to improve the lives of disadvantaged children in villages near Chennai, and widows, single mothers and their families in villages in central Tamil Nadu. I am pleased to report that during the year Sr Deepthi, who has visited Australia on several occasions, has taken on a more prominent role in overseeing project work, reducing the workload on Sr Stella.

During the year Assisi, through our partner Live & Learn Cambodia, supported Self Help Groups led by women in Koh Kong Province, located in the south west near the Thai border, and in Kampong Thom Province on the Tonle Sap lake. Financial literacy and leadership training for women and disadvantaged children has been the focus of our work in Cambodia during the past year. Our project has focused on providing livelihood and business training to improve income generation opportunities for local communities, and through this work reduce the impact on the fragile environment in target areas.

Importantly during 2015-2016, the Assisi CoM has worked on the preparation of its 2017-19 Strategic Plan. During this process, the CoM confirmed that Assisi will continue to focus on empowering women by enabling them to become agents of change in their communities. The approach that Assisi will take is to work to equip poor and disadvantaged women and their children in India and Cambodia with the skills and knowledge to enhance their economic and social participation.

During 2015-16, Assisi continued to develop organisationally with the appointment of four new CoM members, Amanda Scothern, Brigid Mulcahy, Tim Chapman and Dione Brooks. Each brings new skills and experience to the CoM, laying the foundation for the growth of Assisi into the future.

I would also like to acknowledge and thank other members of the Assisi CoM, our Treasurer Andrew

Gilchrist, Past President Tom Dumaresq, and CoM member, Philippa Sholl, for their on-going commitment to Assisi and valuable contributions.

I would like to thank Christian Nielsen who retired from the CoM during the year after many years of dedicated service to focus on his work as Executive Director of the NGO, Live & Learn Environmental Education. We wish him well in his important work in the future.

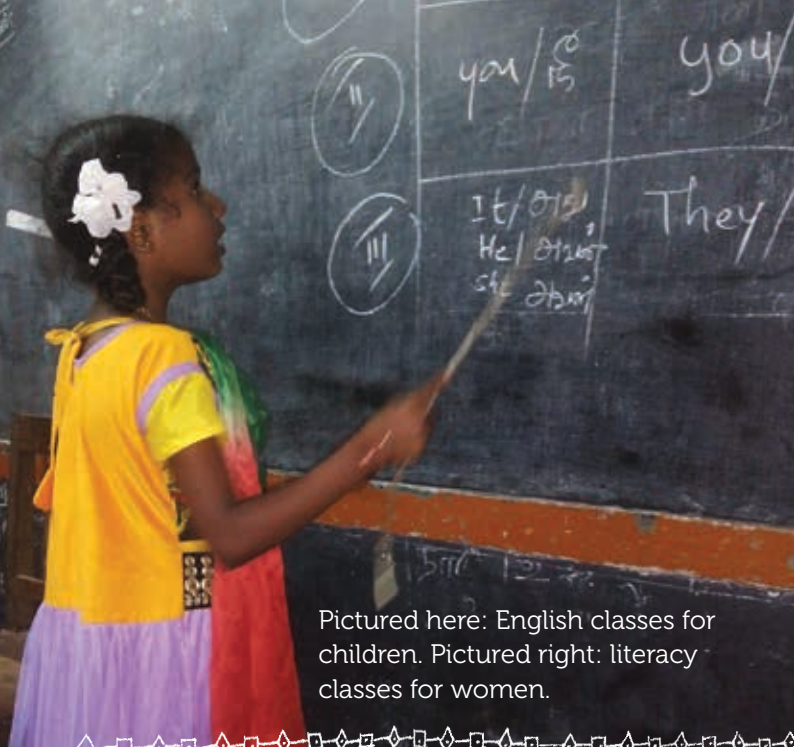

Key achievements:

- 418 women were trained in household business and 205 women took loans for small business ventures.
- Two self-managed women's banks continued with 153 members - helping women to manage savings, take loans, earn interest and keep money within their village.
- Project staff motivated 129 widows to apply for pensions and 215 families to construct household toilets - improving family health and safety for women at night.
- 420 women participated in village level meetings and confidently expressed views on widow's pension, equal wages and their other concerns in the village.
- Assisi provided emergency food parcels for 200 families in Kancheepuram district, affected by floods.
- Below: 74 street rallies raised awareness of rainwater harvesting, health and environmental issues.



36 women participated in a 6 month tailoring course. 10 women have purchased machines and have started sewing at home, while 2 women plan to set up shops.





Stories of change

India

In 2015-2016 Assisi supported two projects in Tamil Nadu, to strengthen people's own capacity to establish, operate and manage their own development initiatives.

Support for single women headed families

In India, widows, divorcees and single women are frequently subjected to discrimination, impacting on their psychological state, dignity, self-esteem and physical health. Deprived of equal opportunities to participate in daily life, many face isolation and poverty.

Assisi has now set up **28 Women's Support Groups** with a total of 850 members. The groups provide a supportive environment for women to connect, build confidence and participate in livelihood, finance and business trainings.

Income generation training includes animal raising, organic farming, food production, tailoring, candle making, setting up small shops and access to microcredit and rolling loans.

Home visits, and group counselling sessions aim to restore women's self confidence and include awareness of human rights and gender equality.

Since joining the Women's Support Groups, many women now have access to an income, which has led to improved health, self confidence and status in the community.

The program has also set up **30 savings groups** for 557 women and **16 village level development** groups with 201 members, including 45 men.

The Assisi self help group approach builds locally-led support structures for long-term sustainable development.



Education for disadvantaged children

The children's project continues to improve education for 1031 children through **23 tuition classes** and **29 children's parliaments groups**.

Children aged 8-16, attended evening study groups, strengthening skills in language, maths and science as well as learning important life-skills such as leadership, child rights, gender equality, health, hygiene and protecting the environment.

This year the project has introduced education materials, which use a participatory and active learning approach. The Eureka toolkit includes picture cards and maths games and have been most popular with the children and their parents.

20 parents groups continued to meet monthly with 251 members. During meetings the groups discussed child health and the importance of education. ❀

Key achievements:

- Top: 17 Model Farmers attended a range of agricultural trainings over the year. They are now passing on this knowledge and skills to other farmers. Mr Loem Chum, (top left) lives in a floating village on the Tonle Sap lake. Through training he has built a floating garden using bamboo and chopped up water hyacinth as soil. Now he is growing water spinach, cabbage, chillies, salad greens, and eggplants.

Stories of change

Cambodia

This project aims to promote sustainable livelihoods to reduce poverty through the strengthening of Self-Help Groups (SHGs) in ten villages in Trapeang Rong and Phat Sanday communes, Cambodia.

The Tonle Sap ecosystem is under serious threat from deforestation, over fishing and poor water quality due to faeces and waste directly disposed into the lake. Trapeang Rong (TPR), located in the Southern Cardamoms Mountains, is one of the last remaining wildlife corridors in Asia. Threats to the biodiversity of the region include habitat loss due to illegal logging, wildlife poaching, and fire from slash-and-burn agriculture. Communities require opportunities to generate environmentally sustainable incomes to improve their standard of living and protect the environment.

This year, **17 Savings Clubs** continued with a total of 393 members (292 female). This community-led bank allows members to pool their funds, earn interest and take loans for small business ventures. The long-term impact of saving clubs is visible in the villages, with improvements in the quality of housing, increased incomes and assets, as compared to our initial survey in 2010.

17 Model Farmers (10 female) were trained throughout the year in organic farming techniques, and are now passing on their knowledge by training other community members. This peer-to-peer learning approach helps in transferring knowledge and experience quickly between community members and builds opportunities to collaborate.

The Trapeang Rong **Community Based Ecotourism Group** was established to provide sustainable alternative livelihoods for local people while reducing threats to local natural resources. This year the Group has accelerated operations, and have a new and stronger committee of 12 members.

The Group conducted a **community education campaign** to raise awareness on the importance of protecting their environment. The campaign included mobilisation of 157 students, teachers, police and commune council leaders. Activities included tree plantings, a street rally, waste collection and 10 environmental signboards placed around the commune (pictured left).

12 children's tuition classes continued this year, supporting 202 students (99 girls) who have been identified as falling behind in studies. As a result, 96% of students from tuition class have passed their studies this year. 🌿

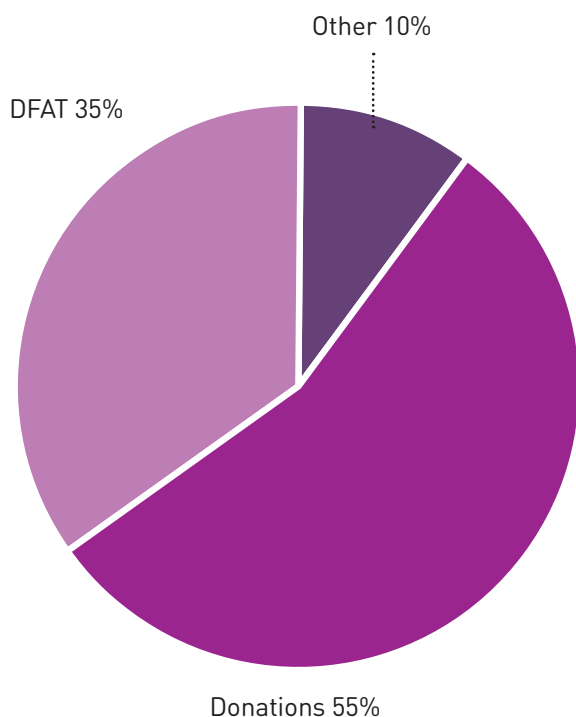
Where our funds came from

- Donations 55%
- Department of Foreign Affairs and Trade 35%

Donations from the Morris Family Foundation, Charity Berfred and Australian Ethical Investment, have been crucial in supporting our projects in 2015/16.

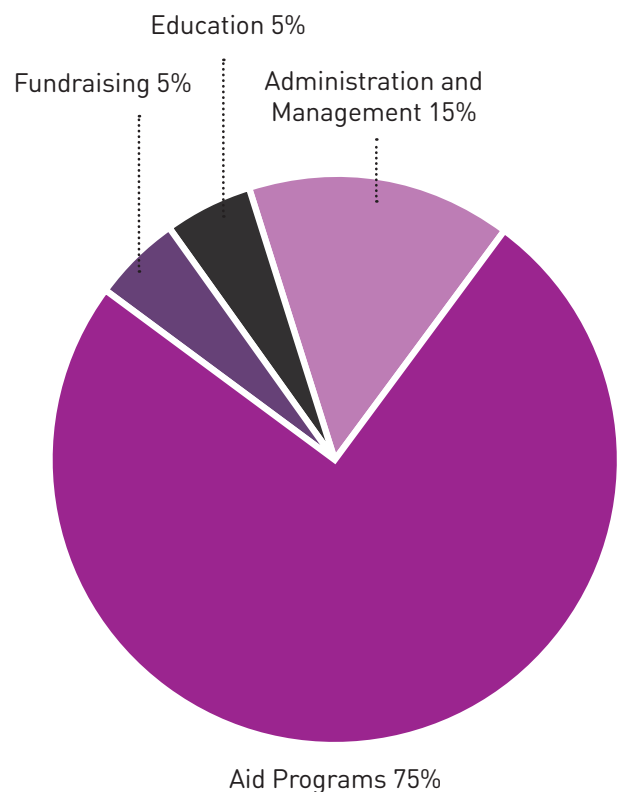


Where the funds went

- International aid programs 75%
- Community education 5%

Total funds expended during the year were \$351,015 of which \$263,155 was spent on overseas projects in India and Cambodia.



Meet the Assisi team

Assisi Aid Projects is governed by a volunteer Committee of Management who ensure good governance, financial integrity and provide support to the Assisi staff and overseas partner organisations. Assisi operations are managed by a team of two part-time staff members, CEO - Karen Young and Finance Manager - Lin Sun. Assisi projects are implemented in India and Cambodia by skilled staff through our partner organisations, Integrated Development Trust in Tamil Nadu and Live & Learn Environmental Education in Cambodia.

Our Partners



Our projects would not be possible without the local expertise and skill of our in-country partners. Assisi Aid Projects would like to acknowledge and thank our partners in India and Cambodia for their work and commitment.

In INDIA, Assisi partners with Integrated Development Trust (IDT) in Kancheepuram district and Perambalur Social Service Society (PSSS) in Trichy district.

Our two projects in Tamil Nadu have a team of 48 staff who are trained specialists in community development.

In CAMBODIA, Assisi has partnered with Live & Learn Environmental Education since 2010. This partnership has provided an opportunity for the transfer of the Self-Help Group model from India to Cambodia. This has seen the successful set up of 17 Savings Groups in rural areas of Cambodia. Many of these groups have been operating now for 6 years.

Update: Floating Education Center

We are pleased to announce the opening of the floating Community Education Centre in Tasom Village, on the Tonle Sap lake, Cambodia.

The opening event was held on October 5th, 2016. In attendance were parents, children, tuition teachers, savings group members and four staff from the Provincial Department of Education, including the Deputy leader.

The centre contains a library, eco-friendly toilets and a water filter to ensure children have access to clean drinking water.

Prior to our project in 2012, children in Tasom village had no access to education due to their remote location. This centre provides a space for 33 children to attend daily classes.

For the first time, children will have access to storybooks and be able to borrow books from a library. The toilet system stores faecal waste in the blue plastic containers until pathogens are dead, while liquid waste is filtered through the plants.
