# Delivering on our 2017-20 Strategic Plan

The Assisi Aid Projects' Strategy 2017-20 aims to strengthen the capacity of women to establish, operate and manage their own development initiatives. The Strategy targets the root causes of gender inequality – embedded in the systems and structures of power and politics – through a focus on fostering equal gender relations and by working with women, girls, men, and boys. In recognition that cultural change can take generations to achieve, a key strategy for attaining sustainable change is to break down gender bias and discrimination by working with girls and boys. This strategy can only be achieved by Assisi Aid Projects working alongside in-country partners who share Assisi Aid Projects' vision.

Assisi Aid Projects has continued to develop as an organisation through the continuous improvement of our policies and operational systems. After review, it was considered that the 2017-20 Strategic Plan remained relevant, so the Committee of Management agreed to extend the timeframe to 2020-22. From 2022, Assisi Aid Projects' strategic approach will be to plan five years ahead, reviewing progress on an annual basis.

# Goal 1: Increase women's social, economic and political empowerment

The focus of our work is on women's social and political empowerment, where we can have the greatest impact. The India Women's project has made advances in collectivising and strengthening the Single Women's Groups at state level to build an inclusive and organised force for change in advocating for the rights and issues of importance to members. Financial literacy, small business skills and loans contribute to increasing women's economic empowerment.

The members of the Gender Task Force in Cambodia have been gaining skills and confidence in participating in civic engagement, and are being heard in community decision making meetings. Members are now advocating for issues of importance to them in the Commune Council and to local government.

### Goal 2: Advance transformational change in institutional and social norms impacting gender equality

The India Youth Project's Children's Parliaments are changing attitudes by promoting gender equality amongst girls and boys who share ministerial roles and learn to respect each other equally. Children's Clubs and classes continually reinforce and model positive gender norms, and the importance of girl's participation and education.

Widows and single women in India continue to challenge the social norms that contribute to their exclusion from community events, decision making, and economic participation. Widows are now more accepted at weddings where they were previously excluded as they are considered bad luck, and their competence in generating income to support themselves is contributing to social change by generating respect of single women in the communities.

# Goal 3: Ensure organisational effectiveness, sustainability and accountability

There have been significant achievements in ensuring Assisi Aid Projects maintains a rigorous set of policies and procedures to ensure organisational effectiveness, sustainability, and accountability. # Goal 4: Enhance organisational and sector learning

Assisi Aid Projects is committed to supporting the capacity development of our in-country partners, and helping them to build their institutional strength and sustainability. In-country partners received training which included: skills required to deliver activities in COVID Safe ways, safe humanitarian distributions, build program management and reporting skills, child protection and disability inclusion knowledge.

As part of our commitment to continuous learning, Assisi Aid Projects' staff attended webinars hosted by the Department of Foreign Affairs and Trade and Australia Council for International Development on COVID-19 response, child protection, disability inclusion, Preventing Sexual Exploitation, Abuse and Harassment, and the Department of Foreign Affairs and Trade reporting requirements.

# When Every Woman Thrives - India Women

Maintaining secure livelihoods during COVID-19 is a challenge. The India Women's Project provides literacy, finance and vocational skills training to widowed and single women. The project now includes understanding and applying COVID Safe preventative methods. Women are trained and supported to sew cloth face masks.


Widowed, divorced, and unmarried women in rural Indian villages and tribal hamlets face discrimination, isolation and poverty. Widows face additional social stigma and discrimination, impacting on their dignity, self-esteem, ability to participate in civic life, generate an income, and health outcomes.

The project aims to improve economic, social, and civic participation of 1775 single women and their families in rural villages in four districts of Tamil Nadu. The project also works across the broader community to confront and attempt to change the traditional or accepted ways of living and thinking that cause women and girls to be treated as less than men and boys in most aspects of life.

This is an integrated income, health (including COVID safe), empowerment and life skills project, implemented through 106 Women's Self-Help Groups and 40 Village Development Committees. The project provides practical skill development for income generation, access to loans to support small enterprises, and education on gender and tribal rights. It raises awareness of the availability of government support schemes including pensions, COVID-19 payments, and subsidies.

I am glad to see that both my children are doing well in their studies and are growing up with good behaviour due to the study centre training. Since COVID there is no school, my children engage in activities at home. They talk to me about child rights, gender and life skills, which is new learnings for me. I am a member of the Parent Committee. Receiving training and phone calls all help us in caring for our children. Rice support was a great help when we did not have enough food to give to our family, especially children.

Children in the rural and tribal areas of Tamil Nadu have few opportunities for quality education, personal development, and future employment pathways. Many are from the Irular tribe, isolated from mainstream Indian society and face castebased discrimination. Whilst most of the children in this district attend government school, it is widely recognized that they require additional education and extracurricular support to pass the government school tests enabling them to move to the next grade.

The project runs in 15 rural villages and 15 tribal hamlets, in each location there is: evening study classes, children's club, Children's Parliament, and Parents' Group. Activities have been adjusted to COVID Safe delivery, and to provide additional support while access to schools is reduced. The project adopts a holistic approach through the delivery of a range of activities which improve children's performance at school in Tamil, English, and maths, while building well-being, life skills, and confidence, and understanding of gender equality. Parents and broader communities are also engaged to understand and value the importance their child's education, awareness of child rights, child protection, and gender equality. Parents and community members have demonstrated an increased commitment to education and children's rights, particularly for girls.

# When Every Woman Thrives - Cambodia

To combat misinformation, front-line volunteers were trained in providing accurate COVID prevention information, hand washing techniques, and COVID safe delivery protocols. Mrs. Tom Sreyleak and other members of Chak Commune received soaps and COVID prevention posters from the Gender Task Force and was happy that the project has informed her and her community in how to prevent the spread of COVID-19.

> Women and youth in Chak Commune, the Cambodia have limited opportunities to create social change and promote their interests and priorities. With low levels of confidence and limited support, participating in Commune Council meetings and working to integrate gender issues into commune plans is difficult.

Women's civic participation is increased by addressing long standing social and cultural structures that create barriers to gender equality and hinder women's engagement. The project increased the participation of women and young people in taking active leadership roles and improving livelihood resilience. The Gender Task Force is a youth led community group working to increase gender equality and leadership opportunities for women and young people. The Gender Task Force has 15 members, working across five villages in Kampong Chhnang Province.

While Assisi Aid Projects and Live & Learn Cambodia have enjoyed a good working relationship, we believe that our partnership is no longer the best way to work towards our organizational goals. Live & Learn Cambodia is focussing on their core activities of environmental and livelihood development, rather than gender equality. Assisi Aid Projects thanks Live & Learn Cambodia for a productive partnership and wishes them the very best in their future endeavours.

# **Our COVID-19 response**

Assisi Aid Projects has been working with our incountry partners Integrated Development Trust and Live & Learn Cambodia, to support communities that we work in to respond to COVID-19. As the situation evolves, so too does our response. Work practices have been adjusted to implement urgent preventative measures and to keep all staff and communities safe by reducing face to face contact and travel. The approach of the projects has been adapted to focus on remote support and prevention of COVID-19 to comply with movement restrictions and to prevent the spread of COVID-19.

# Distribution of humanitarian relief packages

COVID-19 has had a significant impact on people's economic livelihood in Tamil Nadu, India. Financial pressures are compounded by lock down rules and food shortages. With the help of generous donations, Assisi Aid Projects supported Integrated Development Trust in the distribution of rice, cloth face masks, soap, and lentils to the participants in the women and children projects. The relief packages provided more than 17,000 kg of rice to 2463 families across five districts. Staff at Integrated Development Trust ensured safety measures were adhered to during the distribution with measures in place to reduce contact amongst the community and follow physical distancing guidelines.

### When Every Woman Thrives – India Youth

As face to face classes for large groups of children are not appropriate given the COVID threat, the network of community facilitators and tutors provide remote support via telephone where possible to children and their families. To engage children on the importance of COVID-19 prevention, whilst supporting their ongoing education and development, skills innovative new approaches have been needed including home-based educational activities, and COVID safe out-door classes. These approaches encourage children to participate in homebased competitions, such as drawing or writing essays on COVID-19 awarenessrelated topics, using materials which are delivered to their homes.

### When Every Woman Thrives – Single Women

The women in the project continue to be supported through the provision of individual phone counselling for those facing increased personal psychological problems or challenges at home during this time of emergency. The importance of COVID-19 prevention and awareness is communicated through guidance via telephone to individual women by Community Facilitators. The staff contact members of groups on a daily or weekly basis as required to spread accurate information and provide guidance following updates to government instructions.

### When Every Woman Thrives - Cambodia

To prevent the spread of COVID-19, front line volunteers have been trained in COVID Safe prevention measures and have distributed accurate information to the communities. The Gender Task Force, in cooperation with the Commune Council and Health Centre distributed educational posters and leaflets aimed at children and adults to increase understanding of COVID-19 and promote self-prevention including proper hygiene practices and hand washing.

## **Evaluating and monitoring outcomes**

When working with in-country partners, Assisi Aid Projects together with our partners, has developed a range of processes to monitor and evaluate the effectiveness of the projects and apply learnings for continuous improvement. Each year, an agreed plan is developed for each project based on the outcomes of the previous year, and a budget agreed. Our in-country partners provide quarterly written and financial reports against agreed targets. These reports are reviewed and discussed with our in-country partners, and changes to the projects can then be incorporated into the plans after participant consultation.

Our in-country partners also regularly monitor progress by requiring staff to undertake weekly monitoring and data collection activities and through monthly meetings and phone calls with project staff to discuss progress, including challenges, changing needs, participant feedback, potential risks, and improvements.


In addition to regular communication via phone and email, Assisi Aid Projects aims to visit each project annually where it is safe to do so, and requires the projects to be externally evaluated each year. In-country partners are also required to develop and comply with a range of policies and to formally monitor risk. Assisi Aid Projects work alongside our in-country partners to build their capacity where required.

# **Finance Report**



# Independent Auditor's Report To the Members of Assisi Aid Projects Inc.

#### Opinion

We have audited the special purpose financial report (the financial report) of Assisi Aid Projects Inc. (the Association), which comprises the balance sheet as at 30 June 2020, the income statement, the statement of changes in equity and the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the statement by the management committee.

In our opinion, the accompanying financial report of the Association is in accordance with the Division 60 of the Australian Charities and Not-for-profits Commission Act 2012 (the ACNC Act), including:

- (a) giving a true and fair view of the Association's financial position as at 30 June 2020 and of its financial performance for the year then ended; and
- (b) complying with Australian Accounting Standards to the extent described in Note 1, and Division 60 of the Australian Charities and Not-for-profits Commission Regulation 2013.

#### **Basis for Opinion**

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. We are independent of the Association in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 Code of Ethics for Professional Accountants (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### **Emphasis of Matter - Basis of Accounting**

We draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared for the purpose of fulfilling the Association's financial reporting responsibilities under the ACNC Act. As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

#### Responsibilities of the Committee for the Financial Report

The Committee is responsible for the preparation of the financial report that gives a true and fair view and have determined that the basis of preparation described in Note 1 to the financial report is appropriate to meet the requirements of the ACNC Act and the needs of the members.

The Committee's responsibility also includes such internal control as management determines is necessary to enable the preparation of the financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

In preparing the financial report, management is responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intend to liquidate the Association or to cease operations, or have no realistic alternative but to do so.

The Committee members are responsible for overseeing the Association's financial reporting process.

  one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override
  of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Association's internal control.

  are required to draw attention in our auditor's report to the related disclosures in the financial report or, if such disclosures
  are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of
  our auditor's report. However, future events or conditions may cause the Association to cease to continue as a going
  concern.
- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation

# Notes to the Financial Statements

### FOR THE YEAR ENDED 30TH JUNE 2020

#### 1. Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Reform Act 2012 (Victoria), and the Australian Charities and Not-for-profits Commission Act 2012 (Cth). The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

These financial statements have been prepared in accordance with the requirements set out in the ACFID Code of Conduct. For further information on the Code, please refer to the ACFID website www. acfid.asn.au.

These financial statements are compliant with the following Accounting Standards:

AASB 101, Presentation of Financial Statements

AASB 107, Statement of Cash Flows

AASB 108, Accounting Policies, Changes in Accounting Estimates and Errors

## New or amended Accounting Standards and Interpretations adopted

The incorporated association has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

#### Impact of adoption

AASB 15, AASB 16 and AASB 1058 were adopted using the modified retrospective approach and as such comparatives have not been restated. There was no impact on opening retained profits as at 1 July 2019.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

(a) Plant & Equipment

Plant and Equipment is valued at historical cost and depreciated on a straight line basis in accordance with its useful life commencing from the time the asset is held ready for use. New computer assets have a useful life of 4 years and other office assets have a useful life of 2 years.

(b) Income tax

The association is endorsed by the Australian Taxation Office as a charity. It is therefore exempt from income tax. The association is also endorsed as a Public Benevolent Institution.

(c) Reporting Format

These Australian Council for International Development (ACFID)-Code-compliant financial statements comply with the presentation and disclosure requirements of the ACFID Code of Conduct.

(d) Impairment of assets

At the end of each reporting date, the committee reviews the carrying values of its tangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is recognised in the income statement.

(e) Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits at call held with banks, and other short-term highly liquid investments with original maturities of three months or less.

(f) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

#### Grant Revenue

Income from grants that are enforceable and with sufficiently specific performance obligations are accounted for under AASB 15 as revenue from contracts with customers, with revenue recognised as these performance obligations are met.

Income from grants without any sufficiently specific performance obligations, or that are not enforceable is recognised when received.

#### Donations and bequests

Donations and bequests are recognised at the time they are received.

All revenue is stated net of the amount of goods and services tax (GST).

(g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the balance sheet.

#### (h) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as noncurrent assets.

#### (i) Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as current liability with the amounts normally paid within 30 days of recognition of the liability.

(j) Economic Dependence

Assisi Aid Projects Inc. is dependent on the continued financial support of donation receipts and government grant income for the majority of its revenue used to operate the business. At the date of this report, the Committee of Management has no reason to believe that this support will no be forthcoming in future.

#### 2. Administrative donations

Assisi records some non-monetary (in-kind) donations in its financial accounts. These donations mainly take the form of supporters paying administrative expenses on Assisi's behalf. Invoices and documentary evidence support all these entries. Only the actual receipted value of the donation is entered in the financial accounts.

#### 3. Voluntary donations of time and skill

Assisi has elected not to recognise volunteer services as either revenue or other form of contribution received in the income statement. As such, any related consumption or capitalisation of such resources received is also not recognised.

Assisi records the time that volunteers donate and it is noted in the financial statements for two reasons:

- To officially recognise and appreciate the voluntary contributions made by many supporters in helping Assisi
- Certain categories of volunteered time may be counted as Recognised Development Expenditure (RDE). When included in Assisi's externally audited financial accounts, this volunteer time may count for DFAT funding purposes in future years.

#### Australian Administration

Assisi supporters gifted labour to assist with the general running of our Australian operations. From 1 July 2019 to 30 June 2020, Assisi supporters logged 1,953 hours of voluntary labour with a value of \$70,669.

#### 4. Administrative costs

Supporters continue to provide additional human resources during the year on a voluntary basis.

#### 5. Community Sector Bank

Community Sector Banking ABN 88 098 858 765 is a joint venture between Bendigo Bank Limited ABN 11 068 049 178 and Community 21 Ltd ABN 79 097 612 416

#### 6. Events After Reporting Date

Post-year end Assisi Projects has entered into several agreements with external parties for the provision of project funding. The following list outlines the committed project costs for the 2020/21 financial year per the Project Agreements that have been signed:

- a) Enhanced livelihood opportunities for single women families in Tamil Nadu. INR 2,199,050 signed 5 August 2020 with Integrated Development Trust, India.
- b) Improving the educational outcomes of rural and tribal children through an integrated approach of learning, skills development and family health. INR 2,999,940 signed 5 August 2020 with Integrated Development Trust, India

Subsequent to balance date, the Coronavirus (COVID-19) pandemic continues to impact both communities and businesses throughout the world including Australia and the community where the entity operates. This is considered a non-adjusting subsequent event as at 30 June 2020, however, this pandemic will likely have a financial impact for the Association in the 2020 financial year and potentially financial years beyond this date.

The scale, timing and duration of the potential impacts on the Association is unknown.



# **Financial summary**

Assisi Aid Projects had a surplus of \$34,944 for the year ended 30 June 2020. This was a result of savings in staff and operational costs due to government subsidies, slightly reduced overseas programs costs due to COVID-19 restrictions and better than expected fundraising.

Total expenses for the financial year totalled \$376,476 with \$172,311 being applied to International Programs in India and Cambodia. Assisi Aid Project continues to ensure excellent value for money with accountability and administration expenses representing only 12% of total expenditure.

Expenditure on our development work which includes funds to international programs, program support, community education, program design and implementation, training, and monitoring and evaluation.

### Fundraising

Costs associated with attracting more support for our work through donations and grants, and includes marketing and communication costs and processing of donations.

### Accountability and administration

Administrative and other costs involved in running an organisation including finance, human resources, information technology and administration, insurance premiums, professional fees, office supplies and membership of peak bodies.
